**Approval of April 20, 2021 Board meeting minutes:**

Minutes of the April 20, 2021 regular board meeting were read. Motion read by David Klein and seconded by Glen Zierl to approve minutes as presented. All in favor – 3, opposed – 0, motion carried.

Per David Klein – township cannot afford to do the filling and sealing at the same time. Can do the chip filling then do the sealing the following year.

Per Dave Klein also – will make a decision on the next board meeting as he needs to get some information from the county yet.
